#### MARKET COMMENTARY

## Dar es Salaam Stock Exchange Equity Market:

- Tanzania Share Index (TSI) increased by 45.05 points.
- CRDB accounted for about 75% of total volume and 55 % of total turnover, making it the top mover of the month.
- Swissport was the best-performing stock of the month, with a late rally pushing its closing price up by 29%.
- More than 87% of the trading activities were dominated by domestic investors.

#### Financial Results: TCC AUDITED FINANCIAL RESULTS FOR YEAR 2022

- TCC's revenue increased by 8.9% to TZS 340.6 billion due to the successful implementation of its route-to-market strategy.
- TCC has a Compound Annual Growth Rate (CAGR) of 7.6% over the past five years, despite challenges in the tobacco industry.
- TCC's profit after tax increased by 16% to TZS 69 billion in 2022.
- TCC proposed a final gross dividend payment of TZS 370 per share, subject to approval at the annual general meeting in April 2023, with a total dividend payment of TZS 670 per share.
