MARKET COMMENTARY

- In today's Treasury bond auction, featuring a coupon rate of 15.75%, the weighted average yield to maturity (YTM) settled at 14.79%, marking a decline of 48.96 basis points compared to the previous auction. The minimum successful bid was recorded at 105.5917.
- The Bank of Tanzania offered TZS 247.97 billion, while the total amount of bids tendered reached TZS 568.49 billion, representing an oversubscription of 129.25%. Out of this, a total of TZS 80 billion was accepted.
