MARKET COMMENTARY

- For the week under review, total market turnover declined by 22.64% to TZS 12.1 billion, compared to TZS 15.6 billion recorded in the previous week. Total traded volumes declined by 40%, reaching 8.49% million shares from 14.1 million shares in the preceding week.
- TTP, PAL, MKCB, DSE and DCB registered price gains over the week. On the other hand, all other counters recorded price declines.
- The Bank of Tanzania successfully conducted an auction for the 2-year Treasury bond carrying a coupon rate of 10.00%. The minimum successful price was 97.4954, while the weighted average price stood at 99.8880. The weighted average yield to maturity was 10.0481%.
- A total of TZS 107.27 billion was offered against bids amounting to TZS 126.81 billion, resulting in an oversubscription of TZS 19.54 billion. The amount accepted was TZS 107.11 billion.
- Our recently launched Inuka Dozen Index Fund is currently offered at TZS 100 per unit, with the subscription period expected to close on 24th October 2025.
- AFRIPRISE has announced annual general meeting (AGM) which will be held online on 15th November 2025 at 9:00am.




